

**FIRST AMENDMENT TO THE KAISER GYPSUM  
ASBESTOS PERSONAL INJURY TRUST DISTRIBUTION PROCEDURES**

This First Amendment to the Kaiser Gypsum Asbestos Personal Injury Trust Distribution Procedures (this “*Amendment*”) is made by the Trustee of the Kaiser Gypsum Asbestos Personal Injury Trust (the “*Trust*”) with the consent of the Trust Advisory Committee (the “*TAC*”) and the Future Claimants’ Representative (the “*FCR*”) pursuant to Section 8.1(a) of the Kaiser Gypsum Asbestos Personal Injury Trust Distribution Procedures (the “*TDP*”), effective October 22, 2021. Capitalized terms not otherwise defined herein shall have the meaning ascribed to such terms in the TDP.

**RECITALS:**

1. The TDP became effective on August 12, 2021.
2. Section 5.3(a) of the TDP provides that service of process on the Reorganized Debtor(s) may be made, pursuant to applicable federal or state law where the lawsuit is filed, upon the following:

3. By email from counsel for the TAC dated September 2, 2021, the Trustee was advised that the address for service of process on the Reorganized Debtor(s) has changed.
4. Pursuant to Section 8.1(a) of the TDP, the Trustee of the Trust may amend, modify, delete, or add to any provisions of the TDP provided that the Trustee first obtains the consent of the TAC and the FCR. The TAC or the FCR also may propose to the Trustee, in writing, amendments to the TDP.
5. The Trustee has conferred with the TAC and the FCR regarding this Amendment and, as evidenced by the signatures below, the TAC and the FCR both consent to this Amendment. Therefore, pursuant to Section 8.1(a) of the TDP, the Trustee, with the consent of the TAC and the FCR, amends Section 5.3(a) of the TDP as forth herein.




